4. Opening of Bids : September 15, 2017 @ 2:00 P.M.

The BAC will conduct the procurement process in accordance with the revised IRR of R.A. 9184. Bids received in excess of the ABC shall be automatically rejected at the opening of bid.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted to determine the lowest calculated and responsive bid.

Bidding is restricted to Filipino citizens / sole proprietorship, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Bid documents may be secured from the BAC Secretariat Office, upon payment of a non-refundable fee to the Cashier. It may also be downloaded free of charge from the website of Philippine Government Electronic Procuring System (PhilGEPS) and the website of the Procuring Entity, provided that the Bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

Prospective bidders should have experienced in undertaking a similar project within the last two (2) years (for the goods) and ten (10) years (for infra) with an amount of at least 50% of the proposed project for bidding, and have key personnel and equipment (owned, leased or under purchase) available for the implementation of the project. The list of minimum requirement is indicated in the Eligibility Forms.

All particulars relative to eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

The Procuring Entity assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of bid.
