The BAC will conduct the procurement process in accordance with the revised IRR of R.A. 9184. Bids received in excess of the ABC shall be automatically rejected at the opening of bid.

Prospective bidders should have experienced in undertaking a similar project with an amount of at least fifty percent (50%) of the proposed project for bidding, and have key personnel and equipment (owned, leased or under purchase) available for the implementation of the project. The list of minimum requirement is indicated in the Eligibility Forms.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted to determine the lowest calculated and responsive bid.

A complete set of Bidding Documents may be acquired by interested bidders from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronics means.

All particulars relative to eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

The Procuring Entity assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of bid.


